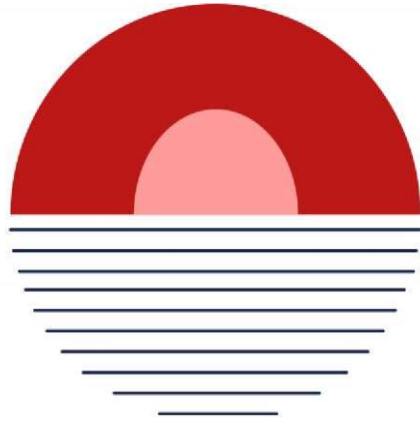

Brady Investment Counsel LLC (“the Firm”) is committed to protecting the confidentiality and security of client information. While providing investment advisory services, the Firm collects and maintains non-public personal information about clients. This information may include personal identifiers, financial account data, custodial information, and details provided by clients during the advisory relationship.

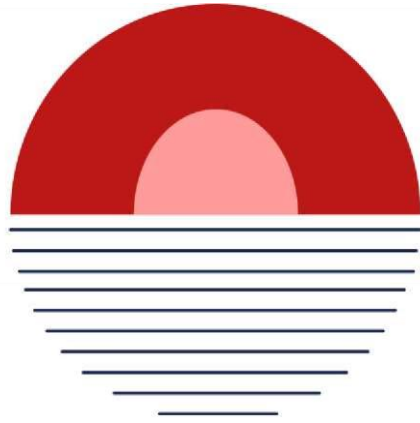
The Firm uses client information solely for the purpose of delivering advisory services, maintaining accounts, processing transactions, and complying with legal and regulatory requirements. The Firm does **not** sell or share client information with non-affiliated third parties for marketing or any other unrelated purposes.

The Firm may share information with certain non-affiliated service providers **only as permitted by law** and only when necessary to support advisory services. These service providers include, but are not limited to:

- **Adyzon, Inc.**, which provides portfolio management, reporting, and technology services
- **Charles Schwab & Co., Inc.**, which serves as the primary custodian for client accounts
- Technology, compliance, or administrative vendors engaged to support Firm operations

All service providers are engaged under written agreements that require them to protect the confidentiality of client information and to restrict its use solely to support Brady Investment Counsel LLC.

Because the Firm does not share client information in a manner that triggers opt-out rights under Regulation S-P, clients are not required to take any action regarding the Firm’s information-sharing practices.
